

New Annuity Rates Effective June 29, 2019

The deadline to lock in current rates is June 28, 2019.

Applications and money must be received in the Home Office by June 28, 2019, 5:00 P.M., Central, in order to lock in current rates. 1035 exchange and transfer money on applications received by end of day on June 28, 2019, must be received in the Home Office no later than August 13, 2019, 5:00 P.M., Central, to receive the current rate.

Rates in **RED** indicate a decrease from the previous rate and rates in **GREEN** indicate an increase.
